WINTER WEATHER TIPS

KEEP OUR COMMUNITY SAFE AND ACCESSIBLE

As winter sets in, we all must play a part in keeping our community safe, accessible, and welcoming. In addition to the usual winter challenges, we are responsible for maintaining clear and safe sidewalks, roads, and homes. Here are some helpful tips to ensure everyone's safety:

Clear Your Sidewalks

In Tooele County, property owners, occupants, and agents are required to clear snow, ice, hail, and sleet from sidewalks promptly. This includes the sidewalks in front of your property and, for double frontage lots, sidewalks on both sides of your property. Corner lot owners are also responsible for sidewalks along the side of their property.

According to Tooele County Regulation 15-4-2: *Sidewalks must be cleared of snow, ice, hail, or sleet no later than 10 a.m. after a storm, especially if the storm occurred between 5 p.m. and 9 a.m.*

Trash Pickup Considerations

If snow piles up and blocks your trash container placement, make sure it's no more than two feet from the edge of the snow or obstruction. Don't block traffic or impede snowplows.

Snow Disposal & Noise Considerations

Please avoid throwing or pushing snow onto roadways or other sidewalks. It's also a courtesy to refrain from using snow blowers between 10 p.m. and 7 a.m. to prevent disturbing neighbors.

Prevent Frozen Pipes

Frozen pipes can cause significant damage to your property. To prevent freezing:

- Keep your home at a minimum of 55°F.
- Caulk holes around foundations and windows.
- Insulate water meters and exposed pipes.
- Let a cold water faucet drip in extreme cold to keep water flowing.

Plowing Reminders

Tooele County plows roads in Stansbury Park during snowstorms. Main streets are prioritized, but residential roads and cul-de-sacs may take longer. If your road hasn't been plowed within 48 hours of the storm's end, contact the Road Department at 435-843-3402.

Plowing Levels of Service:

1. Emergency routes (hospitals, police, fire stations)
2. Major streets and school bus routes
3. Public transportation streets
4. Residential streets
5. Cul-de-sacs
6. Unpaved roads leading to year-round destinations

Other Winter Reminders

- *Driveway and Mailbox:* Clear your driveway and mailbox after plowing.
- *No Parking:* From November 1st to March 31st, it's illegal to park on county streets between 2 a.m. and 6 a.m.
- *Snowplows:* Give snowplows plenty of space, especially when they're using wing plows. Avoid passing them, particularly on the right.

Winter Driving Tips

When driving near snowplows, stay at least 200 feet behind them. Snowplows often have extended wings and may stop unexpectedly. Always be cautious and avoid driving through snow clouds. Additionally, watch out for wildlife, especially in rural or mountainous areas. Ensure your vehicle is winter-ready with proper maintenance.
