

## **Park & Facility Rules**

Stansbury Service Agency (SSA)'s purpose is to (1) provide recreation services and own, operate and maintain the golf course, clubhouse, swimming pool, sailing lake, playgrounds and all equipment, facilities and grounds related thereto; and (2) own operate and maintain the open space and greenbelt lands and all equipment, facilities and grounds related thereto. (See Interlocal Agreement 8/12/1992)

To ensure that the enjoyment of these areas is available to Stansbury Park residents and visitors, the SSA enacts the following rules:

### **Lake Rules**

1. Caution: use at own risk. No lifeguard on duty.
2. No dumping, feeding or harming wildlife.
3. Catch and release fishing is permitted from watercraft and along public shorelines, except near the Clubhouse where swimming is allowed exclusively.
4. Lake visitors shall not enter, cross, trespass or disturb adjacent private land or property.
5. Watercraft must be registered with the SSA and display registration sticker on front port side at all times. Visit [www.stansburypark.org](http://www.stansburypark.org) to register watercraft.
6. No gas powered watercraft allowed.
7. Watercraft utilizing trailers and other transportation vehicles may be launched only from designated launch ramps.
8. Alcohol and tobacco are prohibited.
9. Littering on public waterways is a class C misdemeanor; violators shall be fined not less than \$100/violation. Utah Code 76-10-2701

### **Park Rules**

1. Parks are open daily from dawn to dusk, unless otherwise posted or permitted by SSA.
2. Pets must be on leash no longer than 6 feet, except in designated areas. Owners are responsible for cleaning up after pets.
3. Do not damage, move or remove any park property.
4. Fires, barbecuing and fireworks are prohibited, except in designated areas. Such activities must be attended at all times and must be completely extinguished.
5. Lewd, illegal and/or nuisance activities are prohibited.
6. No alcoholic beverages, except as authorized by the SSA and specially issued permits.
7. No smoking or tobacco use.
8. The use of portable stereos and public address systems must be in accordance with Tooele County ordinances.
9. Drinking fountains are the only water source available in city parks. Water spigots/taps are not available to the general public.
10. Generators, inflatables and are prohibited unless approved in advance by the SSA
11. Trash receptacles are provided for the use of park visitors. No private or commercial litter shall be placed in park receptacles.
12. Solicitation, sales, the distribution of advertisements/flyers and other commercial activities are prohibited unless approved by the SSA.

13. No overnight parking.
14. No motor vehicles allowed on the grass or on maintenance roads.
15. Littering on public lands is a class C misdemeanor; violators shall be fined not less than \$100/violation. Utah Code 76-10-2701

**Pavilion Rules**

1. Pavilions may be reserved online at [www.StansburyPark.org](http://www.StansburyPark.org) or in person.
2. Reservations must be made at least one (1) business day in advance.
3. No refunds will be given with fewer than five (5) business days' notice. All refunds will be assessed a 20% administrative fee.
4. Groups using a reserved area are responsible for clean-up. Any damage or extraordinary maintenance will be billed to the reserving group.
5. No park property shall be damaged or moved.

**Pickleball Complex Rules**

1. Pickleball courts are open from March 1-November 30 (weather permitting).
2. Pickleball hours are 7:00 am to 10:00 pm daily.
3. Courts 5 & 6 may be reserved for a fee in two-hour blocks at [www.stansburypark.org](http://www.stansburypark.org). No refunds. If courts are not reserved, open play is allowed.
4. Open Play. Participants using the courts during open play are allowed one game to 11 points. At the end of the game, all players must vacate the court and announce, "Open Court." When the next group of players takes the court, they are allowed a five-minute warm-up. No exceptions. Please be courteous to others awaiting play.
5. Only SSA-approved leagues, tournaments, and lessons are permitted, all others are prohibited.
